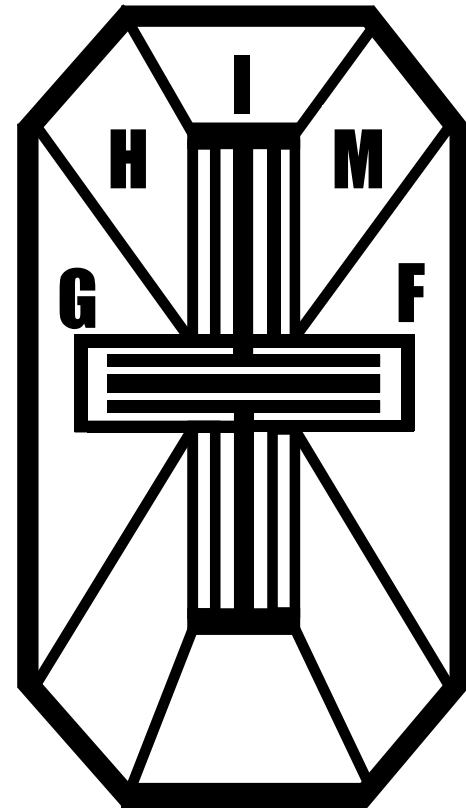

***Constitution and By-Laws of the Greater Huntsville
Interdenominational Ministerial Fellowship***

Preamble

Article I - Name

The name of this organization shall be the “Greater Huntsville Interdenominational Ministerial Fellowship.”

Article II - The Statement of Philosophy, Purpose and Goals

Section 1 - Philosophy and Purpose

Having been led by the Spirit of God to unite together as ministers of God for the purpose of advancing His Kingdom among men, we feel inspired to set forth our aims and goals for the spiritual improvement to the Huntsville Community through the establishment of the following philosophy.

- a. We believe that the Gospel is the power of God unto salvation and that the Gospel must be proclaimed through a united effort by all Christians in the community.
- b. We believe that the local churches can be strengthened through their active participation in the united effort to spread the Gospel of Jesus Christ.
- c. We believe that each pastor in the community has a responsibility for carrying the Gospel beyond his own church.
- d. We believe that it is profitable for all ministers to come together uniting their resources in an all out effort to spread the Good News of Jesus Christ.
- e. We believe that our Christian witness should focus upon the moral and social ills of the community as well as spiritual.

Section 2 - Goals

To foster this philosophy we believe that the following goals should be established:

- a. To identify areas in the community that are spiritually, morally, and socially deficient.
- b. To develop and implement outreach programs which will meet the needs of each particular area.
- c. To formulate outreach programs that will bring the entire community together (i.e., city-wide revival meetings).
- d. To establish a permanent forum for ministerial interaction.
- e. To promote church interaction (i.e., fellowship programs, community-wide choir festivals and Bible bowls).
- f. To establish a city-wide religious education program (i.e., evening courses for ministers, marriage counseling, and gospel music worship).

Article III - Membership

The membership of this organization shall consist of ministers of the gospel of Jesus Christ that meet the qualification criterion for membership as developed by the Membership Committee and approved by this organization. They must also comply with the requirements for membership as set forth in the by-laws.

Article IV - The Officers

The officers of the Fellowship shall be (a) President; (b) Vice-President; (c) Secretary; (d) Assistant Secretary; (e) Corresponding Secretary; (f) Treasurer; and (g) Chaplain.

Article V - Election of Officers

The officers are to be elected for one full term (two years) by a majority vote of the body with the announcement of said election being made in a regularly scheduled meeting two months prior to election.

Special elections to fill vacancies may be held whenever this body deems it necessary, but not without at least one month prior to said election.

Article VI - The Power and Duties of Officers

Section 1 - President and Vice President

- b. The Vice President is the Administrative assistant to the President and shall preside in the absence of the President. Further, he shall as preside as Chairperson to the Fellowship’s Program Committee.

Section 2 - Secretary

- a. He/She shall be director of the bureau of information.
- b. The Secretary shall be custodian of all records.
- c. The Secretary shall receive and record membership monies and transfer them to the treasurer.
- d. The Secretary shall keep records of the proceedings of the Fellowship meetings.
- e. The Secretary shall compile and distribute all minutes to the Fellowship.
- f. The Assistant Secretary shall serve in the absence of the secretary.

Section 3 - Corresponding Secretary

- a. He/She shall handle all external communications and letter writing.
- b. He/She shall assist in the development and printing of programs, brochures and other literuater as needed by the Fellowship.

Section 4 - The Treasurer

- a. The Treasurer shall be custodian of all monies turned in to him.

Section 5 - The Chaplain

- a. The Chaplain shall be responsible for conducting or appointing persons to conduct the devotional services for each meeting.

Article VII - Board of the Fellowship

- a. The Executive Board

Article VIII - Board Duties

Section 1 - Executive Board

- a. The Executive Board shall consist of the Executive Staff and the Chairpersons of each standing committee.
- b. It shall plan and give directions to the Fellowship.
- c. It shall meet each month at least one week prior to the meeting scheduled for the General Body.

Article IX - Committee

There shall be the following committees functioning under the direction of the Fellowship.

- A. Membership Committee
- B. Program Committee
- C. Education Committee
- D. Evangelistic Committee
- E. Ways and Means Committee
- F. Benevolent Committee
- G. Publicity Committee
- H. Social Action Committee
- I. MLK Committee

Article X - Committee's Duties

Section 1 - Membership Committee

The Membership Committee shall:

- a. Work throughout the year to maintain and increase the membership of the Fellowship.
- b. Be responsible for the processing of all membership applications recommending to the general body action to be taken for each person seeking entrance into the Fellowship.
- c. Develop procedures and criterion/qualifications for membership and retention.
- d. Develop application and membership cards.

Section 2 - Program Committee

Purpose: The Program Committee shall plan and present to the Fellowship activities which are recommended by the body.

The Program Committee shall:

- a. Present outlines for Annual Observances.
- b. Plan events which do not come under the responsibility of any other committee.
- c. Be responsible for ensuring that printed programs are available at each GHIMF sponsored activity.

Section 3 - Education Committee

Purpose: The Education Committee shall guide the Fellowship in educational programs of a religious nature. It shall recommend to the General Body the type and form of education program to be sponsored by the Fellowship.

The Education Committee Shall:

- a. Establish an area-wide religious education program.
- b. Develop courses for ministers and the laity.
- c. Develop and supervise religious music workshops.
- d. Establish a permanent forum for ministerial interaction

Section 4 - Evangelistic Committee

Purpose: This group shall provide the Fellowship with the mechanism for proclaiming the Gospel of Jesus Christ throughout the community. It shall unite the combined resources in an all-out effort to spread the Good News.

The Evangelistic Committee Shall:

- a. Develop and recommend outreach programs which shall meet the spiritual needs of each particular area.
- b. It shall formulate programs such as area wide revivals that bring the entire community together.

Section 5 - Ways and Means Committee

The Ways and Means Committee Shall:

- a. Plan and conduct all fund-raising activities for purposes within the scope of the Fellowship's program.
- b. It shall work closely with all standing committees in carrying out their program.

Section 6 - Benevolent Committee

Purpose: The Benevolent Committee shall receive, review and make recommendations concerning all request for benevolent assistance.

The Benevolent Committee shall:

- a. The committee, shall employ the use of churches to provide financial assistance to persons in need.
- b. It shall organize assistance to needy individuals when a request is submitted by contacting any and all organizations which provide assistance.
- c. It shall bring to the Fellowship the names of ministers.

Section 7 - Publicity Committee

The Publicity Committee shall:

- a. Endeavor to secure publicity for the work of the Fellowship in the local press and on radio, television and other media.
- b. Interest persons in charge of local news media of the spiritual, moral and social ills of the community and heighten the communities awareness of the strength of the various expressions of Christianity.
- c. Act as far as possible as an agency for the promotion of the activities of the other committees of this body.

Section 8 - Committees of Social Action

Purpose: The purpose of the Social Action Committee is to identify the social, political and economical deficiencies impacting upon the nation in general, the community in specific and directing the General Body toward plausible solutions of said deficiencies. The Committee is a recommending body and as such will take no action without the approval of the General Body.

The Social Action Committee Shall:

- a. Review all cases relevant to the social, political and economical ills of the community and identify other organizations which may have current involvement in the eradication of those problems.

Article XI - Time and Place

The Fellowship shall hold its meetings monthly or at such time and place as it may be determined.

Article XII - The Official Seal and Emblem

The official seal and emblem of the Fellowship shall be the emblem as presented on the cover of this booklet.

Article XIII - Decorum

This Constitution may be amended by three-fourths votes when the constitution of the Fellowship deem it necessary.

"Roberts Rules of Order" will be followed in all instances not reflected in this constitution or its By-Laws.

By-Laws

1. The membership fee for each minister shall be \$12.00 per year unless otherwise waived by the Fellowship.
2. The requirements for seeking and retaining membership are:
 - a. The applicant must be a minister (Preacher) of the Gospel of Jesus Christ our Lord, and acknowledges the freedom of the Grace of God.
 - b. The applicant must agree to the purposes, goals and the spirit of this organization.
 - c. The applicant must meet the financial requirements of this organization unless otherwise waived by the Body.
 - d. The moral character of the applicant should be one in keeping with the principles of Jesus Christ as well as those of this organization.
 - e. The applicant should show support for the programs of this organization.
 - f. The applicant should comply with the By-Laws.
3. Failure to comply with any of the above, can be grounds for rejection of applicant and/or dismissal from membership.
4. The body reserves the right to reject any applicant or dismiss any member who is disruptive, or whose presence would have and adverse effect on the body.
5. Guidelines for organizational financial support for this Fellowship are:
 - a. Organizations may financially support this Fellowship, but will have no voice in its operations, policies or business.
 - b. Organizations may contribute, who do not oppose either in principle or practice the purpose and/or goals of this Fellowship.
 - c. Contributions may be made at any time and in any amount and may be recognized by the Body for its support.

6. The means of involvement of GHIMF in community activities are:

- a. Approval process -- before the GHIMF is involved in any activity (either ongoing or new) that activity or request should be directed to the appropriate committee for review and recommendation to the Executive Committee and to the body for approval by a vote of the body.
- b. No group activity or member of the fellowship shall use the fellowship's name as supporting that effort without approval of the body.
- c. The program committee shall present to the fellowship in its December meeting the planned activities for the upcoming year.
- d. All items coming to the Executive Committee (not of a general operations nature) shall come to the General Body (after appropriate committee review) in the form of a recommendation for approval or rejection.

7. The purpose and scope of the GHIMF Choir are:

- a. The GHIMF Choir is restricted to GHIMF events unless otherwise approved by the body.
